# Grant helps NYC Crews Create Defensible Space for LHVC Residents

After the tragic 2020 Labor Day Fires took out thousands of homes across Oregon, lawmakers worked to prevent more loss of life and property in the future. Senate Bill 762 was signed into law, and provides funding to help homeowners increase defensible space around their properties.



Northwest Youth Corps established its new Community Wildfire Protection Corps (CWPC) using grant funds provided by the State of Oregon and its Higher Education Coordinating Commission and the Oregon Conservation Corps. The CWPC program hires and trains young adults to remove dead or suppressed vegetation and overhanging trees from around homes and critical infrastructure. Grant funds also support wages to young adults, as well as on-the-job experience.

NYC coordinates with local fire departments to identify worksites. So far, CWPC has assessed 34 properties in the Laurel Hill Valley. Of these, 17 LHV properties have received fuel reduction work, including the Hendricks Hill communal area.

CWPC has received positive media coverage and Senator Floyd Prozanski and state funders recently visited the Laurel Hill crew. For more information about CWPC, please contact Ian Appow at iana@nwyouthcorps.org. Thank you!

# East Ridge Village Update

Phase 6 and Phase 7 - as proposed in the original East Ridge Village 2002 Planned Unit Development (PUD) - has begun and been renamed as East Highland. The PUD consists of a total of 67 homes, including 58 single-family detached homes, and 9 single family attached homes. The privately engineered public improvements (PEPI) construction is scheduled through July 2023 and - weather permitting - home construction is scheduled from August 2023 through December 2024 and streetlights are planned on the main roadways bisecting the property (Deerfern Road and Rockrose Lane). Street names include Deerfern Road, Rockrose Lane, Woodfern Lane, and Woodfern Terrace. Remember this construction area is private property with heavy machinery in use. We ask everyone to stay safe and not wander into the work zone.

Moon Mountain Park is an undeveloped natural area in Eugene's Ridgeline Park system, located north of Coryell Ridge Park and south of Henderson Avenue. Moon Mountain features upland prairies, oak woodland, and conifer forests, and also offers views of the confluence of the middle and coast forks of the Willamette River. Currently, the park is served only by an unimproved logging road. The City of Eugene plans to finish building the first Moon Mountain hiking trail this year. Topic: Basic Design Concepts for Sustainable Landscapes EC 1533

Getting started on a sustainable landscape design for your property is a big undertaking, but it's more intuitive than you think. Working with your landscape, not against it, can help identify problem areas and put those areas to better use.


Topic: Growing Strawberries EC 1307

Picking your own fresh sun-warmed strawberries is one of my favorite things about summer. Strawberries are easy to grow in our region. Before you plant, take a look at the different varieties available and different planting methods. This article will help with soil and nutrient requirements, identifying pests and diseases, and help you decide what kind of plant to choose; June-bearing, everbearing or day neutral.

Topic: Bats in the Garden EC 1611

Bats are especially useful for pollinating plants and eating mosquitoes. I love to watch them take off into the night in search of insects to eat. The air is filled with clicking and chirping as the bats echo-locate their prey overhead. Try your hand at designing spaces for wildlife in your yard as part of your sustainable landscape!
