Serious Problem at STR in our Neighborhood

On the evening of Saturday, January 11, 2020, there was a significant incident involving a short-term rental (STR) on Augusta Street. While there have been prior complaints regarding this particular rental, this incident was particularly egregious, and the Executive Committee of the neighborhood association wanted to provide some information to the neighborhood.

The incident involved about 60 people participating in a house party. Police (EPD) were called, quickly arrived with numerous units, and were able to shut down the party before it turned for the worse. Weapons and drugs were found in and on the property and four people were arrested. Due to the tenacious advocacy of neighbors and some local media attention (via KEZI), the rental is no longer listed on the Airbnb site (at least temporarily).

We advise all Laurel Hill Valley residents to contact the police (in addition to rental administrators or owners) if they have any concerns regarding parties or illegal activity at short-term rentals. EPD does care and wants to help protect our neighborhood. For emergencies (e.g. large parties, violence, drugs, weapons, etc.) dial 911. For non-emergencies (suspicious behavior, vandalism, noise complaint, etc.), call the non-emergency line at 541-682-5111. If you're unsure, call the non-emergency line and give dispatch the information.

Capital Hill/University Heights Update by Tom Bruno

The LHVC and Fairmount Neighborhoods are jointly appealing a recent Land Use Board of Appeal (LUBA) decision. Our attorney feels the new LUBA hearing officials didn't interpret the testimony of our geotechnical expert correctly.

East Ridge Village Update by Tom Bruno

A new modification boundary application was sent to city planners for phases 6 and 7. The result is 13 fewer family lots. There will be a total of 39 single family lots, 6 detached townhome lots, and 14 condominium units. The goal of the developer is to build 8 homes per quarter in phase 5 before private engineered public improvements (roads, storm waters, sewers etc.) construction begins in phases 6 and 7.



Laurel Ridge PUD Update by Stan Dura

The City denied the application in November, and both we and the applicant appealed parts of the decision. The City has decided to allow the applicant six months to finalize their revised plan and another six months to evaluate it, which will include the same participatory rights as the regular process. Thus, there will be another public hearing and the record will be opened for additional evidence and testimony.




Short-Term Rentals (STRs) are everywhere in Eugene. Just looking at the Airbnb website, there are hundreds of potential places to stay. Right now, the Eugene City Council is considering changes to city code to update ordinances regarding how short-term rentals can be operated in the city.

The council has directed staff to create an Ad Hoc committee that will dig into issues regarding STRs to uncover the impact on neighborhoods.

Some who host in the LHV are keenly aware of their responsibility to their neighbors and take that seriously. And some, well, not so much. This is an issue that can and does affect the fabric of the Laurel Hill Valley and it's an important issue to watch going forward. Regardless of where you stand on the subject, STRs are here to stay. But your voice can be heard at city council community comment sessions, writing letters to the editors, and generally becoming involved in the process.

If you are dealing with a situation with a short-term rental near you, first talk to your neighbor to see if you can resolve the issue. Next, call the police non-emergency number (541-682-5111) unless it is an emergency when you should call 911. Be willing to sign a complaint in order to get it on record. And finally, if it's an Airbnb property, call (855) 635-7754 or go to the web page https://www.airbnb.com/neighbors and follow the prompts.
