Eugene is currently working on code amendments to implement a law passed in 2019 called HB 2001. HB 2001 increases housing density in parts of Eugene, including our neighborhood. The code amendments must be completed by June. This is a controversial issue for many neighbors. LHVC is forming a committee to weigh in on behalf of the neighborhood. Development Update and Request for Donations

The Laurel Ridge PUD has been given tentative approval by the City. This is the third time the developer has proposed a development on the approximate 96 acres in the SW corner of the valley over the past 5 years. It will be accessed at Spring Blvd off 30th Ave. It calls for 372 multi-unit homes clustered on 36 acres with the remaining approx. 60 acres preserved as a forest management area that will remain undeveloped. We, Laurel Hill Valley Citizens (LHVC), have worked with the City and developer through the approval process to improve the PUD to the point where it will become a welcome addition to our neighborhood **EXCEPT** for one issue.

That issue is the connection of 30 Ave. through the valley connecting to I-5 at Glenwood and Franklin Blvd. Our concern is the increased traffic through the valley from 30th Ave. and the affect this will have on existing streets. This should be especially concerning to people living on Riverview as a connection will be made to that street. The language of the neighborhood refinement plan clearly states that "there shall be <u>no</u> connection between 30th Ave. and I-5." (The developer doesn't need this connection to build but the City wants the connection.) LHVC has objected to this issue and proposed solutions that should satisfy all parties throughout the approval process without success. We have appealed to the Court of Appeals as our last chance to prevail. Oral arguments were made on January 10th. A ruling will be made in the first quarter of this year.

Responding to land use issues such as this is done by volunteers interested in improving our neighborhood. Literally hundreds of hours are donated by these folks. There are also hard costs associated with these efforts. Filing fees and payment for occasional legal representation are necessary. The LHVC has a fund to address land use issues for this PUD and future developments. To that end we are having a fundraising drive to have the reserves necessary to cover these costs. 




Neighborhood Association Helps Neighbors Fight Trespassing, Dumping, and Other Problems in Our Neighborhood
