Traffic Calming Options for Riverview Street

At the February 19, 2014 neighborhood association meeting, city staff will present a proposed design for traffic calming devices to be installed on Riverview Street and seek community input. The traffic calming devices will be installed because traffic volumes on Riverview increased by over 10% after speed cushions were installed on Augusta Street in 2012. Capital Hill PUD The third proposal in the works for the Laurel Hill Valley

In case you missed the article in the Register-Guard on January 2nd, and haven't heard anything about the 20-Lot Planned Unit Development (PUD) proposed for the top of the ridge on the west side of the Laurel Hill Valley, here is a short synopsis. Dr. Thomas Dreyer and his wife, who live at the top of the hill, are planning to develop a mostly vacant, approximately 13.5-acre property in the vicinity of 2875 Capital Drive as the Capital Hill PUD. The Dreyers have retained Schirmer-Satre Associates, a local planning consulting firm, to prepare the application and assist them with the process. The property adjoins the south side of Hendricks Park and extends east from the top of the ridge to the upper portion of Capital Drive and westward down the slope to the Ribbon Trail. Therefore, the PUD straddles the line between the Fairmount and Laurel Hill Valley Neighborhoods. Based on what is known at the time of this writing, access to the additional single-family homes will be from Capital Drive, in the Fairmount Neighborhood and no roads are planned to connect to Floral Hill Drive or the Laurel Hill Valley.

Currently, the property includes "The Pink House", an Italianate stucco mansion built around 1916, which the Dryers are planning to preserve and, possibly, restore. As of the time of this writing, the layout of the planned PUD is not yet known. Based on the acreage and the number of proposed lots, the average lot size should be right around 2/3 acre, for a density of around 1.5 dwelling units per acre. However, it must be pointed out that as part of the PUD process, homes can be "clustered" in order to provide somewhat higher density in one portion while preserving open space. Homes will reportedly be set back from the Ribbon Trail. According to Schirmer-Satre, the Dreyers are planning to develop the site and then sell building lots.

The PUD is in the beginning stages of the planning process. A mandatory meeting of the applicant (the Dreyers and/or Schirmer Satre) with both the Fairmount Neighborhood Association and the Laurel Hill Valley Citizens is scheduled for February 6, 2014. After this meeting, the applicant will finalize plans and submit them to the City. Once the City has deemed the application complete, the City has 120 days to conclude the local decision process. As a result, a hearing will be scheduled in relatively short order at which both oral and written testimony can be submitted by the public. The Laurel Hill Valley Citizens and Fairmount Neighborhood Association will form a Response Committee whose primary task will be to study the potential impact(s) on our neighborhoods, determine what position the neighborhoods should take and prepare documentation to allow the respective Neighborhood Executive Committees to vote on that position. Once that committee is formed, a contact person will be designated for inquiries from interested parties. Update on Landmark Student Housing Proposal

As most people are probably aware, Landmark, a Georgia firm, has proposed building a 606 bedroom student apartment complex in our neighborhood. The development that they call "The Retreat" would occupy 22 undeveloped acres in the center of Laurel Hill Valley, as well as straddling Moon Mountain Drive. Student traffic to the UO would be borne primarily by the deteriorating section of Laurel Hill Drive that parallels I-5. The LHVC Response Committee's concerns include incompatibility with the neighborhood, size, length and height of the proposed buildings, the scale of the planned grading, tree cutting, traffic and parking problems as well as numerous other issues.

On December 11th the city planning staff sided with the neighbors, recommending that the Planned Unit Development application be denied based on the fact that the Landmark proposal was "too intense" and "not compatible with surrounding development". The public hearing held on December 18 was well attended by neighbors and considerable testimony in opposition to the proposal was given. Hearings Official Ken Helm is now considering the proposal. His decision is due by February 8th. Once received, the decision may be appealed to the Planning Commission. We'll talk about the decision and what happens next at the neighborhood meeting on February 19th.

LaurelRidge PUD Hearing January 9th

On Thursday, January 9th the Oregon Land Use Board of Appeals (LUBA) convened a hearing at 9:00am in Salem, Oregon, to consider the appeal by the LaurelRidge PUD developers of the decisions made by the Hearings Official and the Eugene Planning Commission to deny the PUD application. Stephanie Midkiff and I attended this hour and a half hearing. Attorney Bill Kloos presented the LRPUD case, the City of Eugene attorney Anne Davies defended the City position to deny, and the Laurel Hill Valley Citizens attorney Sean Malone defended the neighborhood position to deny.

The issue before LUBA was whether the Metro Plan Diagram shows any Parks and Open Space designation north of the Urban Growth Boundary (UGB). Counsel for Laurel Hill Valley Citizens and the City of Eugene assert that the parcel contains parks and open space north of the UGB, while counsel for the developer asserted that the parcel is entirely low density residential.

LATEST NEWS: ANOTHER VICTORY. On January 29th the Oregon Land Use Board of Appeals (LUBA) affirmed the decisions of the Hearings Official and the Eugene Planning Commission denying the LaurelRidge PUD application. Neighborhood Disaster Preparedness: Who Me?




